## 2019 Summer Financial Aid Important Information

Summer sessions are considered a Trailer to the Fall and Spring semesters. To be considered for summer financial aid please follow the instructions below:

- You must have completed the 2018-2019 FAFSA prior to June 30, 2019.
- You must meet **Satisfactory Academic Progress (SAP)** requirements, determined after spring grades are processed.
- Changes to your schedule may change your eligibility, resulting in adjustments to your aid and your account after funds have been disbursed.
- **Pell Grant-** If you did not received the maximum Pell Grant award for the Fall and Spring semesters, any remaining funds can be used for the summer based on enrollment, SAP, and other program eligibility requirements. If you have exhausted your Pell Grant eligibility prior to the summer, you may be eligible to receive a summer Pell Grant through the **Year-Round Pell Grant**.
- **PA State Grants** – to apply for a Summer PA State Grant PA undergraduate student should apply online with PHEAA, by August 15th at <http://www.pheaa.org/funding-opportunities/state-grant-program/summer-grant-program.shtml>. Students must be enrolled for at least 6 credits during a 5 week course(s) and taking at least 50% of these credits in class not online.
- **Federal Direct Student loans** – Must be enrolled at least-half time. If you borrowed your annual maximum amount during the Fall and Spring semesters, you will not be eligible for a Direct Loan during the summer term. If your grade level changed upon completion of the spring semester, you will be eligible for the increase in grade level. See the Federal Direct Loan limits at <http://www.cheyney.edu/financial-aid/Loan-Programs.cfm>
  - First time Federal Direct loan borrowers must complete Entrance Counseling and sign a Master Promissory Note (MPN) at [www.studentloans.gov](http://www.studentloans.gov).
- **Direct Subsidized, Unsubsidized and PLUS Loans can only be disbursed when the student has actually begun attendance in a total of six credits.**
- Students officially graduating in August or December may qualify for additional financial aid based on a completed 2019-20 FAFSA.
- Non-degree seeking students are not eligible for any financial aid. Visiting students should contact the Financial Aid Office at their home institution.
