# **Unusual Circumstances**

If you indicated in Sections C and D of this worksheet that there is an *Unusual Circumstance* surrounding your tax filing, please use the information below to determine the documents you must submit to the Office of Student Financial Services, in addition to this worksheet, to complete the verification process.

### **Extension**

- Individuals granted only the automatic six-month extension must use the IRS DRT (Data Retrieval Tool) in FAFSA on the web or submit an IRS Tax Return Transcript to the Office of Student Financial Services after the return has been filed.
- Individuals granted a filing extension by the IRS beyond the automatic six-month extension for tax year of 2019 may provide –
  - A copy of 2019 IRS Form 4868, "Application for Automatic Extension of Time to File U.S. Individual Income Tax Return," that was filed with the IRS for tax year 2019;
  - A copy of the IRS's approval of an extension beyond the automatic six-month extension for tax year 2019;
  - Verification of Non-filing Letter (confirmation that the 2019 tax return has not yet been filed) from the IRS or other relevant tax authority dated on or after October 1, 2020;
  - A copy of IRS Form W-2 for each source of employment income received or an equivalent document for tax year 2019 and;
  - If self-employed, a signed statement certifying the amount of the individual's Adjusted Gross Income (AGI) and the U.S. income tax paid for tax year 2019.

#### Amended Return

An individual who amended an IRS Income Tax Return for tax year 2019 needs to provide the following documents:

- A signed copy of the 2019 IRS Form 1040X, in addition to one of the following:
  - IRS DRT information on FAFSA with all tax information from the original tax return;
    OR
  - A 2019 IRS Tax Return Transcript (that will only include information from the original tax return and does not have to be signed), or any other 2019 IRS tax transcript(s) that include all of the income and tax information required to be verified.

#### Individuals Who Were Victims of IRS Tax-Related Identity Theft

An individual who was the victim of IRS tax-related identity theft must provide:

- A Tax Return DataBase View (TRDBV) transcript obtained from the IRS, or any other IRS tax transcript(s) that includes all of the income and tax information required to be verified; and
- A statement signed and dated by the tax filer indicating that he or she was a victim of IRS tax-related identity theft and that the IRS is aware of the tax-related identity theft.

## Filed Non-IRS Income Tax Returns

An individual who has filed or will file a 2019 Income Tax Return with a U.S. territory, commonwealth, or a foreign nation needs to provide the following:

- A signed copy of the 2019 Income Tax Return;
  OR
- A transcript obtained from a government of a U.S. territory, commonwealth, or foreign nation that includes all of the tax filer's income and tax information required to be verified for the tax year 2019.
